BILL DESCRIPTION (SB184)

VCAP would prohibit the performance of a medical procedure upon or to a minor child, that is intended to alter the minor child's gender [sex] or delay puberty, with certain exceptions. This bill would provide for the disclosure of certain information concerning students to parents by schools.
