#### **Critical Race Theory Continues Its Influence**

Much has been written about Critical Race Theory (CRT), including two articles in this newsletter. Most parents of school age children know by now that CRT is a Marxist ideology that divides all people by race. Covid policies have opened parents' eyes to just what their children are learning.

As reported in the 2<sup>nd</sup> Quarter 2021 Education Foundation Newsletter, the Alabama State Board of Education passed a resolution on August 21, 2021, that forbids indoctrinating students in an ideology that "promotes one race or sex above another." This resolution is a good first step.

"Woke" universities which embrace the sentiments of Ibram X. Kendi (Boston University Director of the Center for Antiracist Research and New York Times best-selling author of How to Be an Antiracist) are teaching our K-12 teachers how to teach. In How to Be an Antiracist, Kendi tells us: "The only remedy to past discrimination is present discrimination. The only remedy to present discrimination is future discrimination." His remarks are a striking contrast to the words of Martin Luther King who famously said: "I have a dream that my four little children will one day live in a nation where they will not be judged by the color of their skin, but by the content of their character." Kendi and others in the CRT movement want to turn the calendar back so that Americans view all actions through the lens of race. Sadly, they want to introduce the youngest and most vulnerable in our society to children's books like: Anti-Racist Baby, Woke Baby and A is for Activist.

We are not naïve. We know there will always be individuals who reject those who don't look like them, but we are in an era of whites adopting children of color, and parents of color adopting white children. Interracial dating and marriages are not uncommon.

The majority of Americans acknowledge the cruelty of slavery. But we also know we have made great strides. Minorities hold positions of power throughout our government including the Supreme Court of the United States. Americans twice elected a black president! And 4 years later a black VP. We know that leftists have seized control of our college campuses. Marxist radicals in the Students for a Democratic Society (SDS) have been patient. ## Once again, state educators show they don't believe parents should have a choice

Sen. Del Marsh filed and moved his school choice bill, dubbed the PCA (Parental Choice Act) last week. Unfortunately, the educational powers that be don't actually believe that parents bear the responsibility for their children's education, nor do they believe that parents have a right to choose anything beyond the [education establishment's] control.

That was made clear last week with messaging from the education establishment as they denied the fact that tax dollars designated for education should follow the student and questioned the intentions of parents to provide for the education of their own children.

The Executive Director of School Superintendents accused religious schools of teaching radical and divisive ideas.

A member of a local school board who testified in the public hearing asserted that the results of the proposed program would be discriminatory in nature and accused it of being essentially a social welfare program for wealthy parents.

Another education leader asserted that students and schools be required to use the exact same textbooks and curriculum of the state in order to participate.

These folks don't seem to understand the harsh truth that there are literally thousands of parents and students who are ready to opt out of the structure they have built, in hopes that there is something better.

Instead, education bosses took the opportunity to lecture parents, insult homeschoolers, and imply that religious schools are radicalized. In fact, they demanded additional accountability for those not currently under their control in lieu of acknowledging the public's desire for educational freedom from their failing system.

Alabama is resting squarely at the bottom of the educational barrel and, despite the cries to the contrary, it's not from a lack of funding. Federal and state dollars have been pouring into the state at record rates for years. The education budgets are the largest they have ever been in the history of the state. The Education Trust Fund (ETF) has doubled in the past 20 years and now tops \$8 billion. Alabama is third in the Southeast in perpupil expenditures while maintaining last or close to last rankings on every assessment.

In short, the dollars have been adding up while the test scores have been going down. It's clear to any objective observer that the education establishment is protecting the ETF rather than the students that the fund was established to serve.

In Senate committee, an amendment was added to require students and schools who opt into the program to take or administer state standardized tests. Why would parents readily submit to testing requirements for a curriculum that mirrors the failing system they're seeking to escape?

Quotes from the "edu-crats" and union bosses included veiled threats toward educational freedoms of home-schoolers and assertions that if parents were going to get state funds for their children (where do they think these state funds come from and who do they think they're for?), then the state was entitled to control the entire process.

Note: there are always strings attached.

In addition to the state-controlled annual testing, State Superintendent Eric Mackey demanded a state registry of all students, including homeschoolers; a state registry of the curriculum the students would be following; and floated the idea of state officials monitoring parents and students in their own homes.

He further demanded that private schools be brought under some sort of state authority for documentation, monitoring & accreditation.

As a bonus, Mackey would also like the ability to decide what types of students private schools may accept and that the whole program be under the authority of the State Department of Education.



#### What's Good About America?

#### We Dare Defend Our Rights

Notice the patch on the uniform of an Alabama law enforcement officer or observe the state motto on an official state car or as you enter the Alabama State House you will find the slogan **Audemus Jura Nostra Defendere**. Why note a phrase from a dead (Latin) language and why is this motto important?

Marie Bankhead Owen was director of the Alabama State Department of Archives in 1923 when the State of Alabama determined this state motto. In a *Birmingham Age-Herald* article of April 23, 1939, Mrs. Owen told the story behind our strong

state motto. In this article, Mrs. Owen referenced a desire to express "a phrase that would interpret the spirit of our peoples in a terse and energetic sentence."

Owen found inspiration from the famous poem of Sir William Jones (1746-1794) **What Constitutes a State?** where Jones wrote:

"Men who their duties know,

But know their rights, and, knowing, dare maintain,

Prevent the long-aimed blow,

And crush the tyrant while they rend the chain;

These constitute a State:

And sovereign law, that State's collected will,

O'er thrones and globes elate"

Drawing from these powerful lines, Mrs. Owen singled out the phrase "We dare maintain our rights" or "we dare defend our rights." Professor W.B. Saffold of the University of Alabama translated the phrase into Latin and thus, the Alabama State Motto was born.

The area now known as the State of Alabama was considered wilderness. In fact, Mississippi grew faster and was settled quicker than Alabama in the early 1800s. Settling our land required courage and toughness. Alabama was a crucial battleground in the War of 1812. Those settlers were largely veterans of the American Revolution or their sons. Alabama has a heritage of loving and honoring liberty.

While our state constitution is much maligned, the fact remains that the Alabama Constitution maintains the strongest Declaration of Rights of any state constitution in the Union, building upon the principle "That the great, general, and essential principles of liberty and free government may be recognized and established." Alabamians have celebrated that liberty by standing in the forefront of defense of our country and remaining among the highest in support for private charities and benevolent operations. Alabamians historically prefer private help over government-coerced assistance.

For this reason, government-controlled healthcare, including vaccine mandates and talk of vaccine passports, has not found support among common Alabamians. When our people feel the pressure of government control, we don't naturally look for centralizing control by a federal system. Instead, "We dare maintain our rights."

In her 1967 inaugural address, Governor Lurleen Burns Wallace said "Be proud to be called an Alabamian, for your courage has nurtured the flame of freedom. So bury me in her hallowed ground and among her good people, because my heart will always belong to Alabama."

#### Go Woke or Go Broke? by Elaine Little, Editor

Have you heard the acronym ESG lately? It stands for Environment, Social, and Governance. It is a measurement of how well corporations meet the criteria for what has come to be called "woke capitalism". Proponents say it is a way for socially conscious investors to screen potential investments rather than basing their investments solely on financial performance. If one wonders why a company has "gone woke," it may be that they are courting that socially conscious investor class or that the upper management has itself bought into this agenda.

If corporations meet the criteria of being a socially "responsible corporation", sensitive to the social needs of society as visualized by the liberal politically elite, it gets a high ESG score, thus more likely to appeal to this millennial investor class. If not, the business gets a lower score and may suffer accordingly. What are the main agenda items of this liberal investor class? According to an article published in *Epoch News* on February 15, 2022, entitled "Woke Capitalism is a Monopoly Game", author Micheal Rectenwald wrote that such items include identity politics, gender pluralism, transgender rights, lax immigration standards, climate change mitigation, and so on. Such agendas greatly favor large corporations at the expense of smaller businesses because they can better afford any financial impact. Woke capitalism is also called "stakeholder capitalism" which puts the social values of investors, employees, etc. equal to or above financial performance.

When a corporation adopts policies that reflect liberal values, it is coming to be known as a "woke" company. They have accepted the idea of "woke, not broke" or they just want to avoid being "cancelled" by the Twitter mobs. As an example, recently Coca Cola, Inc. had a training program for employees telling them to "try to be less white" as it promoted Critical Race Theory.

This Environment, Social, and Governance Index or score is very similar to the Chinese social credit score. China's criteria is compelled by the government of the Chinese Communist Party, both on companies and individuals. When they comply, they are allowed privileges, when they do not, those privileges are withdrawn. The ESG score is similar but it is not imposed by the government (at least not yet). When companies have a low ESG score, they can be squeezed out of the market. Woke investment drives ownership and control of production away from the noncompliant.

Stakeholder capitalism plays right into the agenda of the World Economic Forum led by Klaus Schwab. Rectenwald quoted Schwab who wrote in 2020: "Every country, from the U. S. to China, must participate and every industry, from oil and gas to tech, must be transformed. In short, we need a "Great Reset of capitalism." In this country, BlackRock, Inc. and Vanguard, the first and second largest investment companies in the U.S. respectively, are solidly behind stakeholder capitalism. So, it is little wonder that companies are increasingly adapting to this way of doing business.

Could such a system of social ratings come to apply to U. S. citizens as it does for Chinese subjects? We tend to think that our Constitution will protect us. But, beware there is a program called ID2020 Alliance Partners. The partners are Microsoft, Rockefeller Foundation and Gavi, the Bill Gates funded vaccine promoting group. They are pushing this "need" for a digital identifier worldwide. This reeks with the stench of the New World Order. If we were to move to a digital currency as proposed by HB 4741, all digital currency, which would be managed by the Federal Reserve Bank, would have a unique serial number. Such currency would have to be tied to an owner of that currency who then also would have to have a unique digital identifier. Such a digital identify could easily be used by the government for any tracking purpose. Along with enhanced facial identification software (developed by Microsoft for China) and cameras on every street light, China tracks its people and controls their lives by debits and credits to their social credit score allowing or removing privileges accordingly. Thus, our every move could be tracked and our every expenditure monitored. Every digitized health record, academic records, licenses, certifications, affiliations, political party affiliations, etc. could be tracked by the federal or any level of government. Your pay would be deposited in your Digital Wallet and expenditures removed from your Digital Wallet.

As our world becomes increasing digital, our quest to protect our freedoms becomes increasingly harder to do. We must continue to educate ourselves and our youth on this new danger.
