## *Climate Alarmists Seize Control*

### THE 15-MINUTE TRAP

In order to seize more control of people's lives, Globalists are pushing the false idea that "15-minute" cities will "save the planet" and help all of humanity.

Fifteen-minute cities are popping up everywhere, and the World Economic Forum is wildly enthusiastic about them. Last year it was announced that Paris, France, would become a 15-minute city, and now the British city of Oxford is next. However, outraged Brits are fighting back.

The Oxford city council has announced that it will divide Oxford into 15-minute neighborhoods, or small 15-minute towns, which are billed as "greener, cleaner and safer." These new "green" cities, which make services accessible to residents within 15 minutes of their homes, are supposed to "save the planet" and help all humanity.

Instead, they are nothing more than a way for them to restrict, coerce, fine, punish, surveil, and limit the fundamental right of freedom of movement for residents. For example, residents are not allowed to leave their 15-minute city by car more than the government-allotted times a year. Violators will be fined. **R**estructuring of Canadian mayors and municipalities under the auspices of the United Nations began in 1992. Prime Minister Brian Mulroney signed Canada onto U.N. Agenda 21. Canada thus became a U.N. member nation-state. 178 countries signed on, lured by the promise of big money to go green. By 2000, countries, including Canada, were being governed by directions of the U.N., G7, G20, World Economic Forum and World Health Organization.

## COP 28: FOLLOW THE MONEY

**T**he sleek private jets winging their way to the Arabian Desert, where Dubai, United Arab Emirates is hosting this year's U.N.-sponsored Conference of the Parties (COP) confab, are carrying their typical load of high rollers from the corporate and foundation world, all of them eager to show their grave concern for the future of the planet's climate.

At COP28 (for the 28th such gathering), they will join hands with delegates from well over 100 countries and thousands of climate activists to bewail the inevitable disaster facing the earth unless urgent measures are taken to counter the "climate crisis." If all of this sounds drearily like previous COPs, take heart: The script for COP28 has been flipped. Yes, countries will again pledge to slash their carbon emissions by a date certain. But such promises (which were never kept) will now have to take a backseat to the real business of COP28: money — and lots of it.

Now it's time for industrialized countries to make amends for all the climate-related suffering they are said to be inflicting on poorer countries. And what better way to do that than by forking over loads of cash to those who present themselves as victims of fossil fuels.

### "Loss and Damage Fund"

The transition from emissions targets to cool cash has been swift.

A U.N. report released last year said that at least \$2 trillion yearly by 2030 will be needed by developing countries to cope with climate-related disasters and to help them down the path of "sustainable" energy use. Various green development funds — transfers of taxpayer money from predominantly middle-income earners in wealthy countries to rich elites in poor countries — have been proposed at previous COP meetings. But the pot of gold never materialized, because most industrialized countries no more kept their financial commitments than they did their emissions targets commitments.

At Dubai, the slush fund has been rebranded as the "Loss and Damage Fund"; it's now being proposed under the guise of paying for "loss and damage" incurred by poorer countries. Think of it as climate reparations. The recipients not only have their hands out for taxpayer money. They also hope to pocket largess from the private sector. Purveyors of green energy, many of them already well healed, are eager to get into the game.


"In the clean-energy transition, investments can be the major driver for progress," said Jake Levine, the chief climate officer of the U.S. International Development Finance Corp., a federal agency that helps fund economic development in poor countries," the *Washington Post* (Nov. 30) reported.

COP28 is crawling with pri-

vate-sector investors and "philanthropists" licking their chops over the deals they hope to close that will bring such things as solar panels and windmills to impoverished communities in the Global South.

"The sideshow is now the big tent," Beth Viola told the *Post*. She should know. Viola is an energy lobbyist at the silk-stocking law firm of Holland & Knight who served in the Clinton administration and as an environmental adviser to Al Gore when he ran for president and to John Kerry when he was in the U.S. Senate.

Kerry is heading the U.S. delegation in Dubai but will be joined later by Vice President Kamala Harris. Joe Biden is sitting this one out as is China's Xi Jinping. Kerry is seeking an agreement to clamp down on methane emissions, a not-too-subtle way of crippling natural gas production. He also is pushing for an agreement in Dubai that would end permitting for coal-fired power plants unless they are outfitted with expensive equipment to limit greenhouse-gas emissions, which poor countries cannot afford. Xi's China controls the supply chain for wind and solar power and for the raw materials that go into batteries for EVs and serve as backup electricity when the wind doesn't blow and the sun doesn't shine. He's also overseeing the construction of coal-fired power plants all over China.

Don't count on China to contribute anything to the Loss and Damage Fund. The Chinese have better things to do with their money. 



# U.N. WANTS YOUR HAMBURGER

**T**he world's most-developed nations will be told to curb their appetite for meat as part of the first comprehensive plan to bring the global agrifood industry into line with the Paris climate agreement.

The United Nations' Food & Agriculture Organization will publish recommendations on eating in a vain attempt to reduce global temperatures by 1.5 degree Celcius. Nations that over-consume meat will be advised to limit their intake, while developing countries — where under-consumption of meat adds to a prevalent nutrition challenge — will need to improve their livestock farming, according to the FAO.

From farm to fork, food systems account for about a third of global greenhouse gas emissions and much of that footprint is linked to livestock farming — a major source of methane, deforestation and biodiversity loss. Although non-binding, the FAO's plan is expected to inform policy and investment decisions and give a push to the food industry's climate transition which has lagged other sectors in commitments.

The guidance on meat is intended to send a clear message to governments. But politicians in richer nations typically shy away from policies aimed at influencing consumer behavior, especially where it involves cut-

ting consumption of everyday items.

"Livestock is politically sensitive, but we need to deal with sensitive issues to solve the problem," said Dhanush Dinesh, the founder of Clim-Eat, which works to accelerate climate action in food systems. "If we don't tackle the livestock problem, we are not going to solve climate change. The key problem is overconsumption."

The average American consumes about 127 kilograms of meat a year compared with 7 kilograms in Nigeria and just 3 kilograms in the Democratic Republic of Congo, according to the FAO data. The Eat-Lancet Commission recommends people consume no more than 15.7 kilograms of meat a year.

The Rome-based U.N. agency, tasked with improving the agricultural sector and nutrition, is seeking to strike a balance between the climate transition and ensuring food security for the growing global population. So as well as calling for less meat consumption for the world's well fed, the plan would also encourage farmers in developing countries to bolster productivity of their livestock and supply more sustainably.

Other recommendations will cover issues from how farmers adapt to an increasingly erratic weather to tackling key sources of emissions like food waste and post-harvest loss or fertilizer use, according to the FAO. The plan will be rolled out in three parts over the next few years to eventually include country-specific recommendations.


The road map has the potential to offer a "shared direction of travel" for livestock companies and their investors, mirroring the role of the

International Energy Agency's net zero document for the energy sector, according to FAIRR Initiative, an investor network focused on intensive animal production.

"This road map is needed to bring clarity to both companies and investors so that they can plan for the transition," said Sofia Condés, head of investor outreach at FAIRR. "The longer companies wait to act, the more drastic and potentially disruptive the transition."

The FAO's work is one of several food-focused announcements and pledges that are expected to come out of the COP28 summit in Dubai. While climate summits have tended to steer away from agrifood issues largely due to sensitivities over food security, this year's organizers are trying to push through a number of initiatives outside the formal talks, said Clim-Eat's Dinesh.

"I see more people coming, more events, more activities around food systems," he said.

The United Arab Emirates have called on governments to sign a declaration committing to include food transformation into their national reduction and adaptation plans. The COP28 summit will have a Food, Agriculture and Water Day on Dec. 10, a first-ever day dedicated to food systems, which encompass anything from how food is grown, processed, distributed, consumed or thrown away. Catering for the summit will be two-thirds plant-based.
